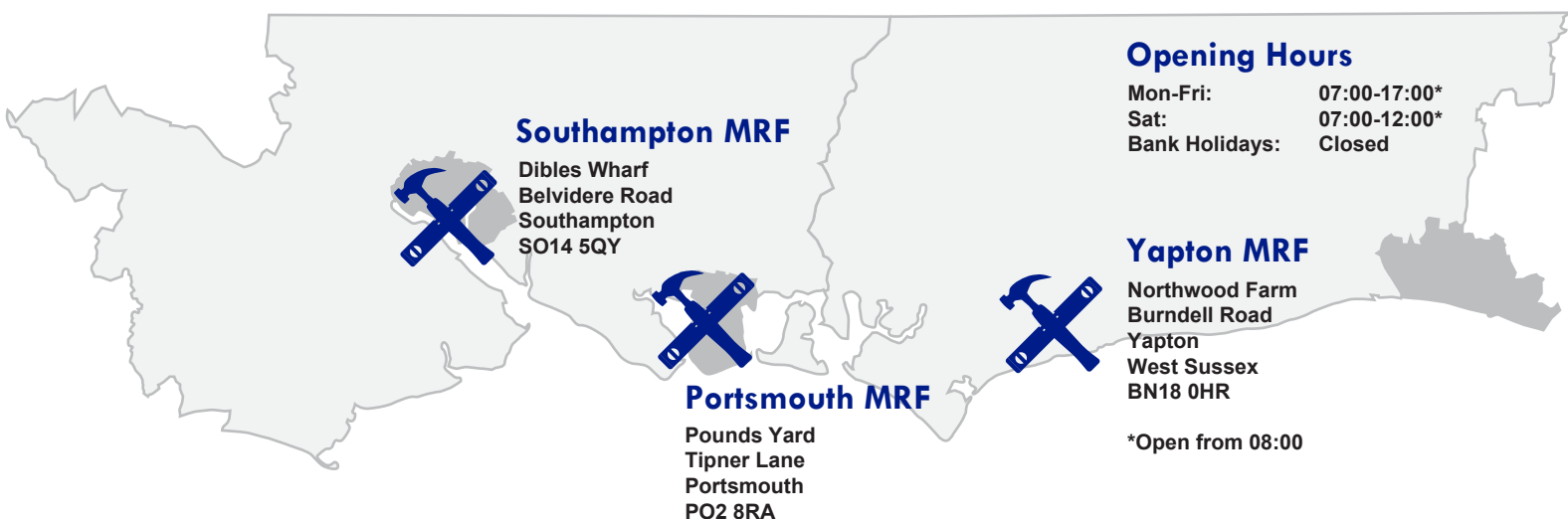

**Small POPS:** Any wasted upholstered domestic seating <40kg



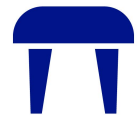

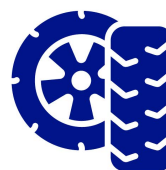

# FIRST TIME USING OUR DISPOSAL SERVICE?

## Required Information

To enable us to process the transfer of your waste to our facility, we're legally required to obtain certain information. To help make this process quicker, please try to have the following information readily available on your first visit:

- **Name of waste carrier (company and personal name)**
- **Your registered address**
- **Phone number**
- **Email address**
- **Waste carriers licence number and expiry date**
- **Address of waste source**
- **Waste description and classification (EWC Code)**

## Payment Security/Deposit

If you do not have an account with prior agreed prices, you must ensure you have a Visa/Mastercard credit/debit card or cash to pay for our service. We require that new customers provide payment security by holding your chosen payment type at the weighbridge until the transaction is complete. Failure to do this may result in refusal of service.

## Personal Safety

Your safety is very important to us, so to use our facilities you will be required to wear a minimum standard personal protective equipment:

- **Hard hat**
- **Hi-visibility top**
- **Trousers (no shorts)**
- **Safety boots (S1P and SRA spec)**
